This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

For an Unattended Funeral service, the following terms apply: -

- Full Payment is required at the point of arrangement.
- No discount or early settlement offer

For an Attended Funeral Service, and all other funeral related services, excluding memorialisation, the following terms apply: -

- All disbursement (3rd Party) charges and 15% of our professional service fees must be paid in full and in advance of the funeral being conducted. We reserve the right to postpone the funeral until such charges are paid in full. Payment must be made at least 48 hours in advance of the funeral date.
- Full Payment of goods and/or services provided, are due within 28 days of us providing you with a valid invoice.
- We may charge interest on the overdue amount at the rate of 10% a year above the base lending rate of the Bank of England from time to time. This interest shall accrue daily from the due date until the date of actual payment of the overdue amount, whether before or after judgment.
